THIS AMENDMENT TO THE DECLARATION OF CONDOMINIUM FOR PHASE II OF VISTA COVE CONDOMINIUM as recorded in Book 759, Page 353 of the Pender County Registry is made this the 15 day of September 2022 by Nicholas Juan Martinez, Inc., Priscilla Rivera and Crystal Marie Beck being at least Sixty-seven percent (67%) of the unit owners of Vista Cove, Phase II Condos.

WITNESSETH:

WHEREAS, The original declarant, Ambrogi Development Co., Inc., caused to be filed in the Pender County Registry a certain document entitled, "DECLARATION OF CONDOMINIUM FOR PHASE II OF VISTA COVE CONDOMINIUM" ("Covenants") in Deed Book 759, Page 353, as it relates to Units A1-A10 Vista Cove Condominium, Phase II, (said units making up the "Association") as they appear on that certain plat recorded in Condominium Map Book 1, Page 41 of said Registry; and
